

1. Use of Bureau Veritas UK Limited Certificates and Identification Number

- a) Any certificate issued remains the property at all time of Bureau Veritas UK Limited. Its display or use being subject to continuing and effective compliance and implementation.
- b) The Bureau Veritas UK Limited identification number (0041), shall only be used on products, packaging, documentation or certificates where the Installer has signed the appropriate declaration of conformity and the item to which it applies is in full conformity with the applicable Regulations.
- c) The Identification Number shall be placed adjacent to the UKCA Marking, see below for example:



Rules for Using the UKCA Image

You must make sure that:

- if you reduce or enlarge the size of your marking, the letters forming the UKCA marking must be in proportion to the version set out below
- the UKCA marking is at least 5mm in height unless a different minimum dimension is specified in the relevant legislation
- the UKCA marking is easily visible, legible and indelible

2. Suspension and withdrawal of Certificates

- a) Installers may suspend certificates at their own request. To do this, installers must provide the request to suspend certification in writing giving the reasons for the request. Bureau Veritas UK Limited will review the request and if the decision to suspend is upheld, certificate suspension shall remain until the installer requests for approval be reinstated. A request to reinstate certification will be followed by an exceptional surveillance visit and once compliance is confirmed, the certificate will be reinstated until certification expires or until approval automatically ceases.
- b) Bureau Veritas UK Limited reserve the right to suspend or withdraw certificates upon evidence of a breach of the rules for the Use of Certificates and Identification Number, or non-payment of agreed fees. Such action may result in an investigation to determine the products that have been placed on the market that are not in conformance with the applicable Regulations.
- c) Where it is identified that Lifts have been put into service that do not conform to the applicable Regulations, Bureau Veritas UK Limited reserve the right to require these Lifts to be brought into conformity or for the Bureau Veritas UK Limited identification mark to be removed from those Lifts. Failure to bring such Lifts into conformity will result in the notification of this information to the appropriate authorities.
- d) Bureau Veritas UK Limited may prescribe corrective actions to remedy the breach within a realistic time limit for implementation, normally within one month.
- e) Additional Surveillance visits (at the Installers expense) may be specified until such time that Bureau Veritas UK Limited have regained confidence in the Installers ability to effectively implement the appropriate systems.
- f) Where corrective actions are not effectively implemented, Bureau Veritas UK Limited will withdraw approval and notify the UK Authority, and other Approved Bodies.
- g) Installers have the right of Appeal.

3. **Suspension**

- a) Upon suspension of approval of a quality assurance system the Installer shall, until the matter is resolved;
 - i) Cease the use of the Bureau Veritas UK Limited identification number (0041)
- b) Installers have the right of appeal.

4. **Termination**

- a) Upon termination of approval of a quality assurance system, the installer shall:
 - i) Cease the use of the Bureau Veritas UK Limited identification number
 - ii) Cease the use of Bureau Veritas UK Limited's name in any documentation or advertising
 - iii) Return to Bureau Veritas UK Limited appropriate certificates.
- b) Installers have the right of appeal.
